- ___ Our chapter will have 14 officers/board members.
- ___ Our chapter will acquire a post office box.
- ___ Our chapter will open a checking account. Federal ID #570044167.
- ___ Our chapter officers and board will meet monthly. Our membership will be invited. This may be a business meeting with program, meal, etc.
- ___ Our chapter will mail a monthly newsletter to our members and to the Pride editor to announce the next meeting, list accomplishments, projects, etc.
- ___ Our secretary will send a copy of our minutes on form #10 to national after each board meeting.
- ___ Our treasurer will send a copy of our financial report and inventory control report on form #11 to national each month.
- ___ Our chapter will form three committees in January to use as needed: ethics/grievance; election; nominating.
- ___ Our chapter will hold a "Pioneer Activity Day" annually for our chapter member's children and/or area youth.
- ___ Our chapter will hold an annual awards banquet - formal, covered dish, pig pickin', etc.
- ___ We understand our chapter will be billed for Pride ad.
- ___ We understand our chapter will be billed for mailing labels.
- ___ Our inventory list from national is ___ is not correct ___ and must be returned to National.
- ___ We understand form #5, Local Chapter Responsibilities, will be completed annually by our chapter president and returned to national by December 31st. Our project money will be withheld from our chapter if we have not completed our obligations above.
